Position Summary

The Fresh Air Fund is hiring a Maintenance Associate for our summer programs at Camp Junior. The role requires the person to perform day-to-day maintenance at The Fresh Air Fund's Camp Junior, located in Harriman State Park. The ideal candidate is hard working, personable and detail-oriented with the ability to work independently.

This position is based at Harriman State Park and will report to the Facilities Manager.

Employment period: Mid-June through at least August 26, 2021 with the potential for additional work in the fall.

There is a mandatory orientation.

Hours per week: Hours per week vary with a maximum of 40 hours per week. Weekend work required.

Compensation: Salaries starts at \$14/hour.

Responsibilities

- Mow, rake, and cut grass.
- Maintain the cleanliness of the grounds through daily trash pickup and removal.
- Perform grounds equipment and vehicle maintenance.
- Support in the maintenance of roads and driveways.
- Make minor building repairs.
- Perform minor tasks of a semiskilled nature such as carpentry, screen repair, painting, plumbing, and minor electrical maintenance if needed.
- Assists full time Maintenance Technicians.
- Other duties as assigned.

- Must be in good general health, able to lift heavy objects and perform basic manual work on a regular basis.
- Must have the ability to be flexible and adjust to changes quickly.
- Must have the ability to work independently and in a team environment.
- Handle concerns/issues in a constructive manner.
- Work outdoors in all weather conditions.
- Excellent written and oral communication skills.
- Proficient with basic computer skills.
